WE PURCHASED 16 ACRES OF LAND TO ADD TO THE ALLEN CREEK WETLANDS STATE NATURAL AREA SOUTH OF FORT ATKINSON AND THE LAST REMAINING PRIVATELY-OWNED SHORELINE (10 ACRES) AT THE 280-ACRE AMEY POND WILDLIFE REFUGE IN ADAMS COUNTY. AT ANTHONY BRANCH FISHERY AREA SOUTH OF THE VILLAGE OF OREGON IN DANE COUNTY, WE PLACED A PERMANENT CONSERVATION EASEMENT ON A 181-ACRE FARM THAT PROTECTS THE HEADWATERS OF THE CREEK.
